Michigan currently <u>does not</u> require pre-licensing training and a certificate prior to taking the licensing exam.

## Step 3: APPLY FOR YOUR LICENSE

The license fee varies per license type (see below)

**On-line application** The State of Michigan uses the National Insurance Producer Registration (NIPR) online application at <u>www.nipr.com</u> on the left hand navigation bars choose "Licensing & Renewal Application", choose "Apply for a new license" (Resident). Scroll to the bottom of the page and click "Begin". You will be required to pay the license fee over the internet. Print a completed copy of the application, receipt and follow up page for your records.
